ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (NOTICE UNDER SUBSECTION 53(1)) RULES 2003

IN exercise of the powers conferred by subsection 53(1) and section 66 of the Road Transport Act 1987 [*Act 333*], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Road Transport (Notice Under Subsection 53(1)) Rules 2003**.

(2) These Rules come into operation on 15 April 2003.

Notice ordering appearance in court

2. Every notice served by any police officer, road transport officer or traffic warden under subsection 53(1) of the Act shall be in the form specified in the Schedule as follows:

- (a) every notice served by any police officer shall be in Form 1;
- (b) every notice served by any road transport officer shall be in Form 2;
and
- (c) every notice served by any traffic warden shall be in Form 3.

Revocation

3. The Road Traffic (Section 45A Notice) Rules 1982 [*P.U. (A) 160/1982*] are revoked.
